This amendment makes the following clarifications: This project has an extremely challenging terrain. There are rocks and boulders on the surface and projections of ledge and drop offs. Access to Stones Ranch Military Reservation may be restricted from November 25 through December 31. 1. Bids will include top and bottom fence rails. 2. Top and bottom selvage will be twisted. 3. Posts will be Allied SS40. Terminal/corner posts will be 3" diameter, line posts will be 2 1/2" in diameter; top, bottom and brace rails will be 1 5/8" diameter. 4. Ties will be 9 gauge steel. 5. Barbed wire will be aluminized chain link fabric with 1.2 oz coating. Previously issued plans SK-1 and SK-2 are deleted from this project. SK-3 and SK-4 are added. Clause 52.228-1 is incorporated.

**SUMMARY OF CHANGES**

SECTION 00700 - CONTRACT CLAUSES

The following were previously included by reference and are now included by full text:

52.228-1 BID GUARANTEE (SEP 1996)

(a) Failure to furnish a bid guarantee in the proper form and amount, by the time set for opening of bids, may be cause for rejection of the bid.

(b) The bidder shall furnish a bid guarantee in the form of a firm commitment, e.g., bid bond supported by good and sufficient surety or sureties acceptable to the Government, postal money order, certified check, cashier's check, irrevocable letter of credit, or, under Treasury Department regulations, certain bonds or notes of the United States. The Contracting Officer will return bid guarantees, other than bid bonds, (1) to unsuccessful bidders as soon as practicable after the opening of bids, and (2) to the successful bidder upon execution of contractual documents and bonds (including any necessary coinsurance or reinsurance agreements), as required by the bid as accepted.-

(c) The amount of the bid guarantee shall be twenty (20) percent of the bid price.

(d) If the successful bidder, upon acceptance of its bid by the Government within the period specified for acceptance, fails to execute all contractual documents or furnish executed bond(s) within 10 days after receipt of the forms by the bidder, the Contracting Officer may terminate the contract for default.-

(e) In the event the contract is terminated for default, the bidder is liable for any cost of acquiring the work that exceeds the amount of its bid, and the bid guarantee is available to offset the difference.
